## RIGHTS OF THE INTERESTED PARTIES

Right to obtain access to personal data and the following information:

- confirmation as to whether or not personal data are being processed;
- the purposes of the processing;
- the categories of personal data;
- the recipients or categories of recipients to whom the personal data have been or will be communicated;
- if the data are not collected from the interested party, all available information on their origin;
- the existence of an automated decision-making process, including profiling;
- a copy of the personal data being processed.

## Rectification, cancellation or limitation of processing (art.16, 17 and 18);

Right to object at any time to the processing of personal data, including profiling, in particular in the event that:

- 1. the processing takes place on the basis of the legitimate interest of the owner, subject to explanation of the reasons for the opposition;
- 2. Personal data are processed for direct marketing purposes.
- 3. The processing takes place for sending commercial communications and advertising material or direct sales

Right to portability of the data of the interested party or the right to receive in a structured format, commonly used and readable by automatic device, the personal data concerning him / her provided to a data controller and possibly transmit them to another data controller, if the processing is based on consent or on a contract and is carried out by automated means. Where technically possible, the interested party has the right to obtain the direct transmission of data from one data controller to another

Right to withdraw consent at any time; the data, if they do not rest on another legal basis (including, fulfillment of a legal obligation or execution of a contract) must be deleted by the owner.

Right to lodge a complaint with the Guarantor for the protection of personal data, following the procedures and indications published on the official website of the www.garanteprivacy.it.

The exercise of your rights may take place by contacting the Data Controller or if designated the Data Protection Officer (DPO) referring to the contact details above.
